## **E. RISK MANAGEMENT**

*Chief James Ortega and Commander Joseph Wren arrived at 10:06 a.m.*

### **E.1. Grant Funds Historic Usage Report**

Mr. Marcus Beverly indicated this is the fourth year of the Police Risk Management Grant. Mr. Beverly reviewed the Grant Funds Historic Usage report by member and noted that only 50% of the fund had been disbursed to date. The main purpose of the grant is for body-worn cameras (BWC) however, if agency's BWC program is fully funded, the grant may be used for other risk management function. Mr. Beverly indicated the Board will start the budget process in Spring 2018 for the FY 18/19 and encouraged members to use their grant.

Discussion ensued whether to set a deadline for member to use the grant such as 'Use It or Lose It' approach and option to redistribute the unused funds to agencies who would use it. Final determination was tabled to the February 2018 meeting.

Chief Sockman indicated Galt is in the proposal process with a couple of body-worn camera manufacturers.

It was noted that City of Willows outsourced their police services to the County.

### **E.2. Body Camera Update**

Mr. Kline indicated that member agencies have shared qualitative evidence using body-worn cameras.

Chief Ruffcorn shared the advances of artificial intelligence in body-worn cameras exhibited at the IACP (International Association of Chiefs of Police) Conference held in Philadelphia last month. The auto transcription features are paving the way to keep officers from writing reports.

### **E.3. Legislative Update**

Mr. Tom Kline indicated five bills that were introduced in the California Legislature during the 2017-2018 Regular Session have been approved by the Governor:

1. Assembly Bill AB 44 - Reyes. Workers' Compensation: Medical Treatment: Terrorist Attacks: Workplace Violence (Bill Approved by the Governor on 10/13/17)

2. Assembly Bill AB 90 - Weber. Criminal Gangs (Bill Approved by the Governor on 10/12/17)
3. Senate Bill 29 - Lara. Law Enforcement: Immigration. Agency Firearm Accounting (Bill Approved by the Governor on 10/5/17)
4. Senate Bill 54 - DeLeon. Law Enforcement: Sharing Data (Bill Approved by the Governor on 10/5/17)
5. Senate Bill 65 - Hill. Vehicles: Alcohol and Marijuana: Penalties (Bill Approved by the Governor on 9/11/17)

Mr. Beverly indicated that AB 44 was a direct result of the Santa Barbara incident. There is an uptick of PTSD (Post-Traumatic Stress Disorder) related claims particularly in public safety personnel.

#### **E.4. Round Table Discussion**

Galt Police Chief Sockman asked about AB 748 - video and audio recordings. The bill was introduced during the 2017-2018 legislative session but did not become a law.

The Committee discussed the future police meeting schedule. The PRMC members want to keep meeting every three months. The current 2018 meeting schedule is February, May, August and November.

The Committee reviewed historical, current and future training schedule:

- August 2, 2017 - Community Policing, presented by Rick Braziel
- November 2, 2017 - Lexipol and Legal Update, presented by Ken Wallentine
- February 2, 2018 - Below 100 by Dale Stockton
- May 3, 2018 - Skelly hearings, Peace Officer Bill of Rights and Brady Requirements by Carl Fesseden

Discussion ensued about possible Crisis Intervention Training resources.

Discussion about outer carrier vests including potential grant sources and suppliers were discussed. Chief Thompson of the Dixon police indicated some shoulder pain issues with the existing carrier vests.

Mr. Kline reminded the Committee of CJPRMA Annual Law Enforcement conference on November 28, 2017 from 9:00 a.m. to 4:30 pm at Livermore; and on November 29, 2017 from 9:00 a.m. to 4:30 pm at Sacramento.

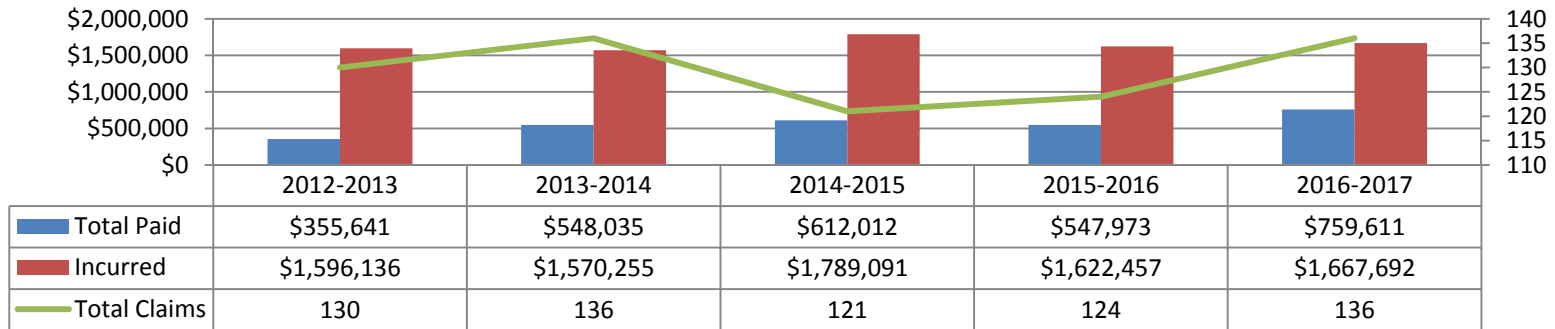




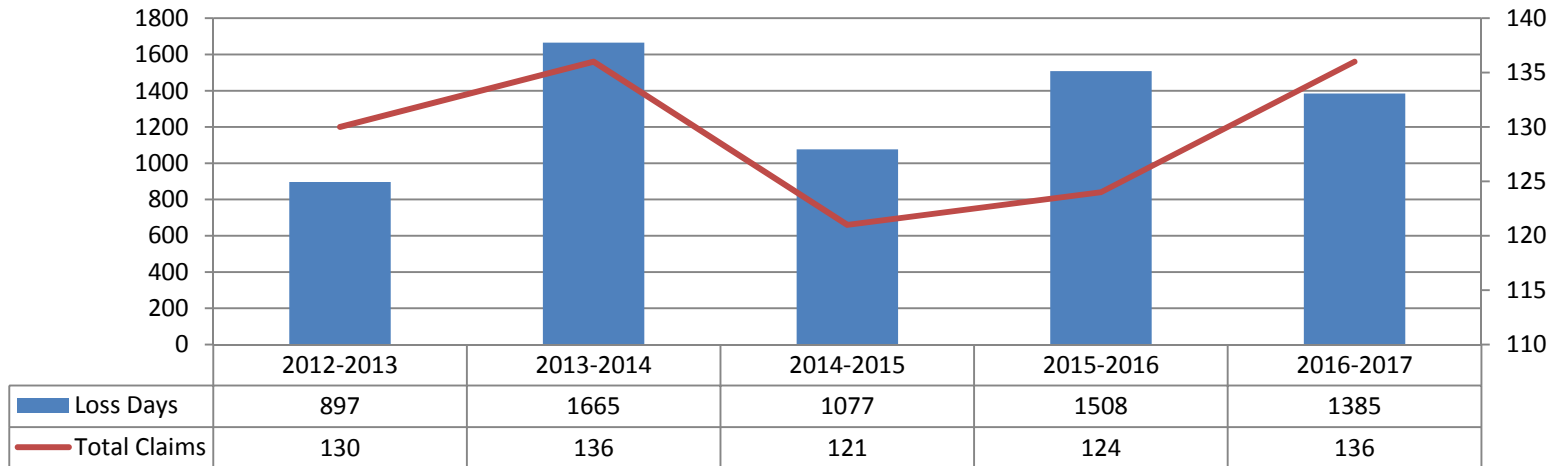

### Total Paid and Incurred by Fiscal Year for Injuries within Fiscal Year

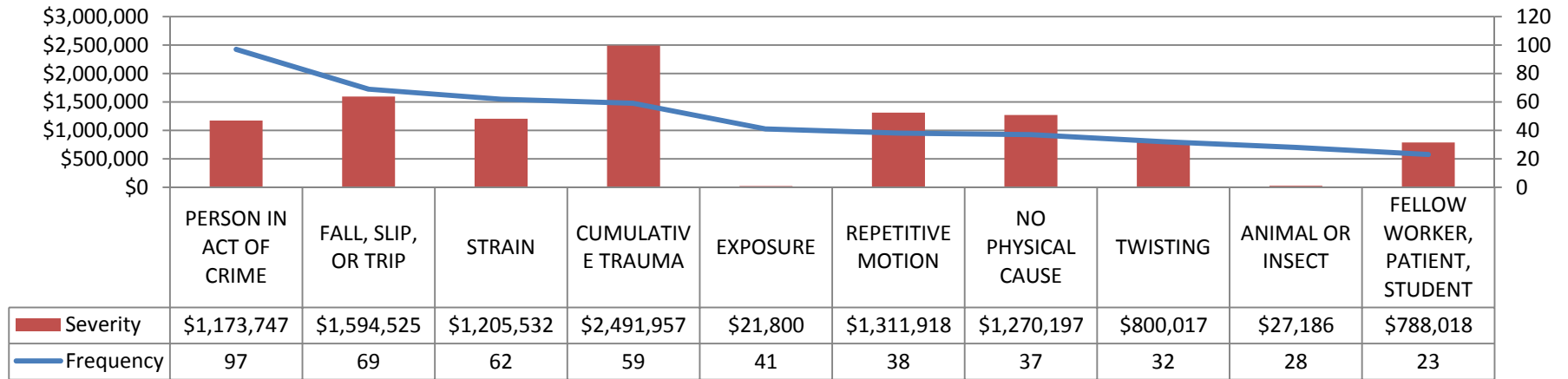


### Loss Days for Injuries within Fiscal Year

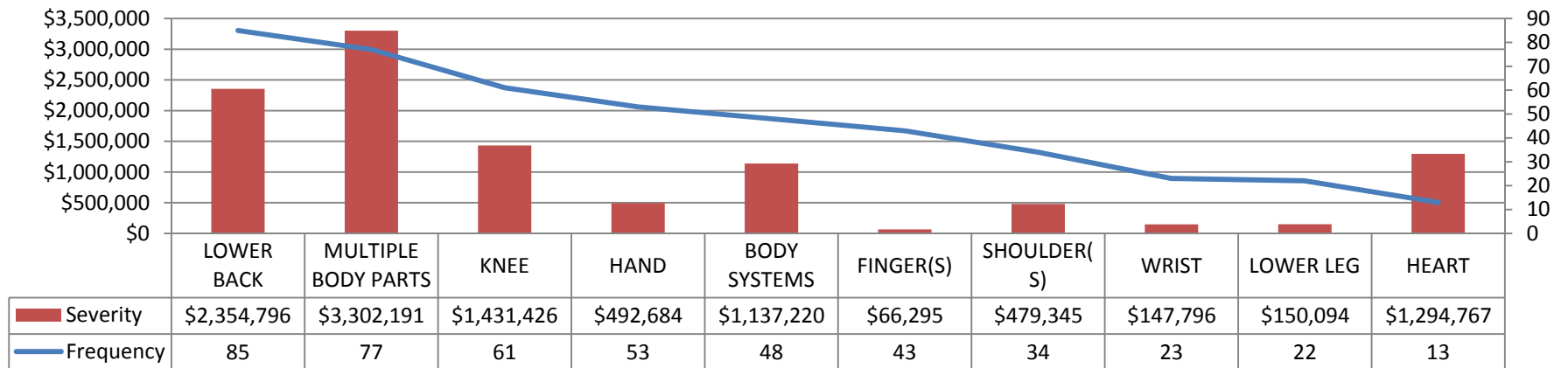


## Trending Report: Workers' Compensation – NCCSIF Police - 2012-2017

### Top 10 Cause of Injury FY 2012-2017

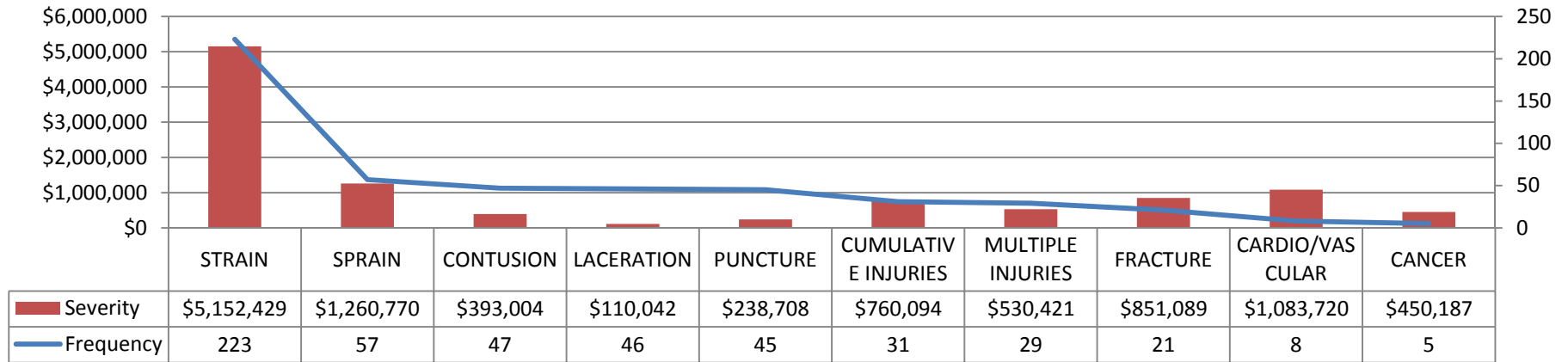


### Top 10 Body Parts Injured FY 2012-2017

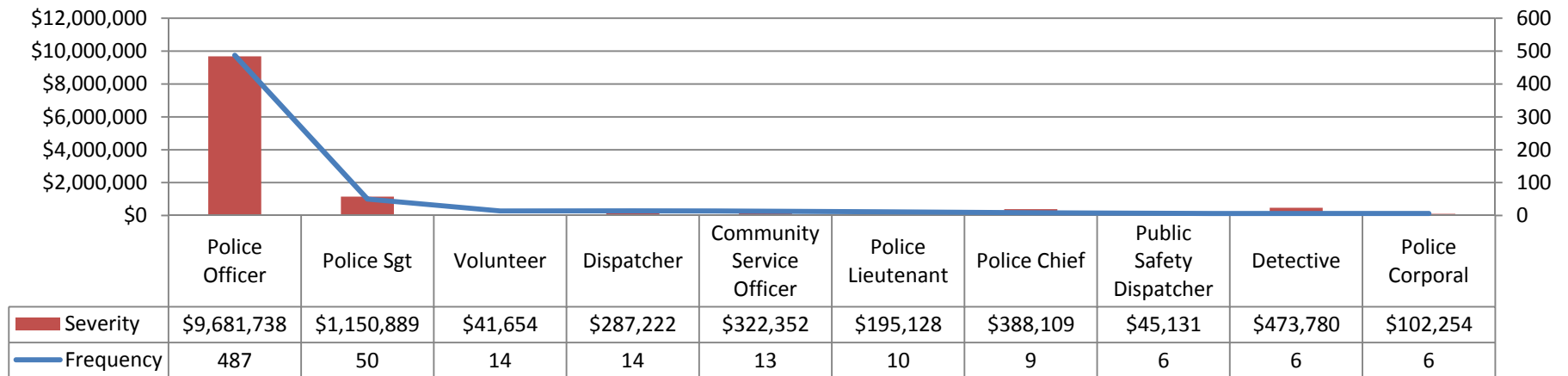

### Top 10 Nature of Injury FY 2012-2017

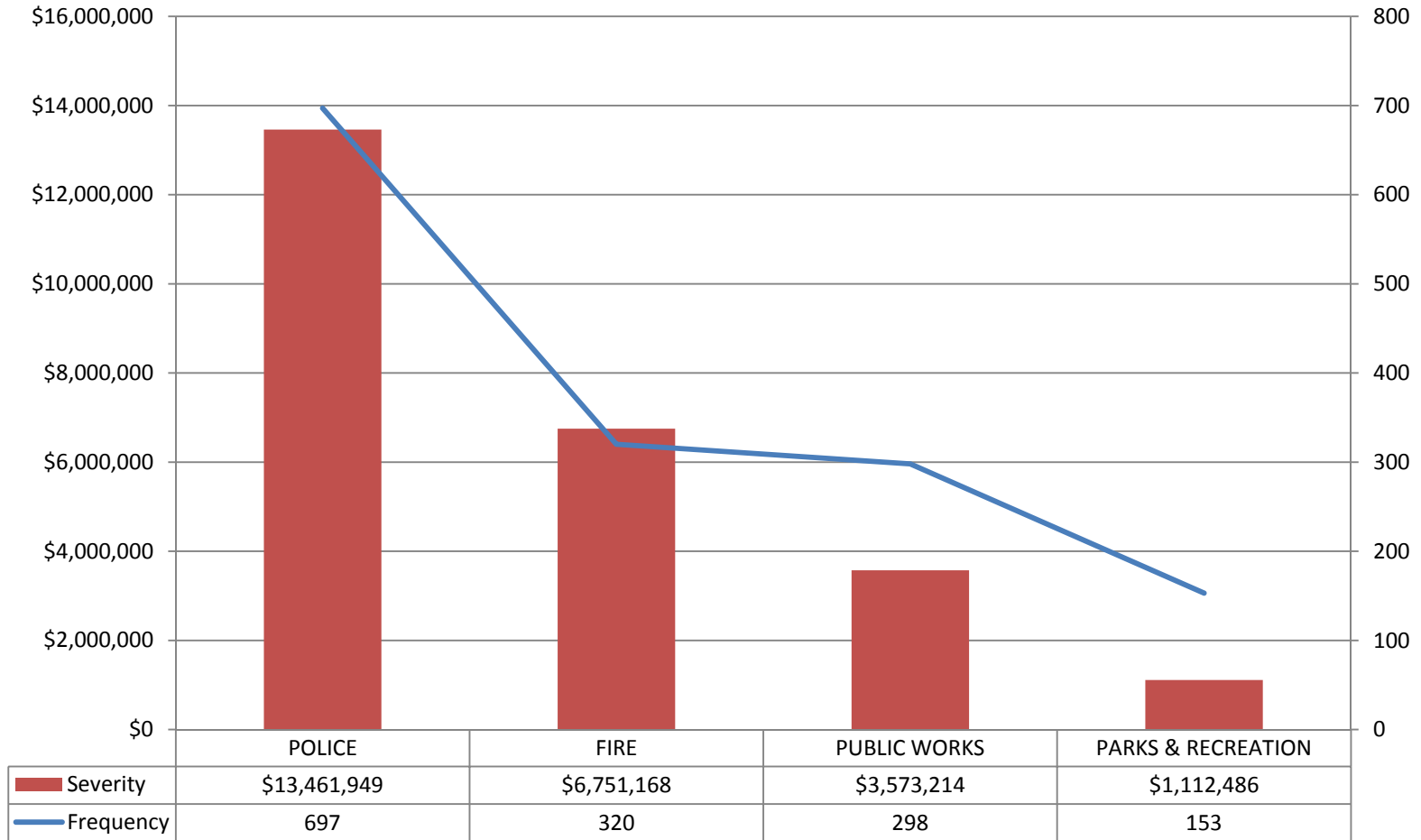


### Top 10 Occupation of Injury FY 2012-2017

## **POLICE RISK MANAGEMENT GRANTS**

### **ACTION ITEM**

**ISSUE:** In the last four years, the Board has approved a total of \$200,000 in grant funds for Police Risk Management. The Grant Funds Historic Usage Report is included to ensure members are aware of the available grants for their agencies. The Committee must take action on the remaining funds from past years to justify additional funding for FY 18/19 to leverage support of the Board.

**RECOMMENDATION:** Determine future grant funding and use.

**FISCAL IMPACT:** To be determined.

**BACKGROUND:** The Board approved a FY 14/15 budget of \$50,000 for the purchase of body cameras for NCCSIF's police agencies. The funds were used to purchase a total of 58 cameras directly from VieVu at a quantity discount. Two members used the funds to purchase different cameras and two have yet to take advantage of the funds. The FY 15/16 and FY 16/17 budgets of \$50,000 were allocated to the members to fund their body camera programs, or if the body camera program is fully funded member agencies have option to use the funds for other risk management functions. The FY 17/18 budget of \$50,000 was allocated to the members for general risk management use.

### INFORMATION ITEM

**ISSUE:** Chief Jeremiah Fears of Corning Police Department will be present to discuss his department's experience with the recent Active Shooter incident in Tehama County. He will also discuss their emergency response plan for an Active Shooter situation and their interactions with the school district, including the need to clear classrooms before releasing students. Members will be encouraged to share their experiences, plans, and best practices.

**RECOMMENDATION:** Share best practices which can provide guidance for developing and implementing procedures in response to an Active Shooter incident.

**BACKGROUND:** Effective response to an Active Shooter incident requires planning and training for employees and other personnel prior to an incident, as well as for leaders and managers who will be coordinating their response to the event. There may be a need to evacuate or shelter in place depending upon circumstances unique to that event. Organization leadership and managers coordinating the response to an Active Shooter event need to prioritize providing effective direction to personnel in the vicinity of the Active Shooter, providing clear status information to first responders, and informing the public.
